III. Financial Report

Derek Goodson reported that the SCISD as at November 30, 2016, had collected assessments and late fees totaling \$110,946.54, and had a cash balance of \$445,239.13. Only the previously approved \$53,853.19 expense for the Wells Fargo Bond was reported. Outstanding bond and loan balance were reported – Wells Fargo Rand Bond - \$620,210, OSLI #119 (Water System) - \$376,120, and OSLI #122 (Water Meters) - \$196,682. Thompson Palmer is working on the audit of the SCISD FY2016 accounts. Upcoming obligations to Wells Fargo and the Office of State Land Investment Fund for the water meter loan was reported – Wells Fargo Rand Bond - \$53,853 (Jan and July), OSLI #119 (Water System) - \$28,847 (May), and OSLI #122 (Water Meters) - \$12,293 (June).

Mr. Goodson reported that the SCISD has received invoices from Frank Hess for work related to the JH Airport Board sewer agreement, and from Val Kotter for sewer cleaning and inspection.

Mr. Goodson reported the Audit of the SCISD accounts is in the final stages with a draft anticipated in very near future. Once completed, a copy must be submitted to the Wyoming Department of Audit with a December 31, 2016 deadline.

IV. Old and New Business

Mr. Price reported that the project had been completed, and that in his conversations with Nelson Engineering that the project has been completed to their satisfaction.

Mr. Price reported that the JH Airport will be tying into the Gros Ventre Utility, and therefore the SCISD sewer systems in the very near future. Once JH Airport connects, they will have ten days to forward a connection fee of \$57,595.57. As part of the agreement, the SCISD is to conduct a visual inspection of that portion of the sewer line from the existing lift station on Spring Gulch Road to where the line connects to the Town of Jackson. The original intent was to have Val Kotter make this inspection, but they did not have the correct equipment.
